No. S.O (R-II)(4)27/2015-S&GAD/3073-322 In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Education Department (Schools Branch) (Women's Section) (Basic Pay Scale 1 to 15) Service Rules, 1984, namely:-

In the aforesaid rules, in the Appendix,-

(a) under the Heading-I Provincial Cadre,-

(i) after Serial No. 1 the following new entry shall be inserted:-

"1-A	Junior Elementary Teacher, (BPS-15).	Associate Degree at least in (Second Division) in Education from a recognized University.	By initial recruitment."

(a) (i) Bachelor's Degree at least in (Second Division) with Arabic from a recognized University; and (ii) Arabic Teacher Training Certificate (ATTC) from Allama Iqbal Open University or from any other HEC recognized Institution; or (b)(i) Al Shahdat-ul-Alia (Equivalent to Bachelor's Degree) at least in Second Division from Wafaq-ul-Madaris, Tanzeem-ul-Madaris or from any of the HEC recognized Institution; and (ii) Arabic Teacher Training Certificate (ATTC) from Allama Iqbal Open University or from any other HEC recognized Institution; or (c)(i) Sanad Dars-e-Nizami at least in Second Division)from a recognized Institution; and (ii) Arabic Teacher Training Certificate (ATTC) from Allama Iqbal Open University or from any other HEC recognized Institution.	By initial recruitment.

(a) Bachelor's Degree at least in Second Division from a recognized University with Certificate of Teaching from a recognized Institution; and (b) One year's training in respective trade from a recognized Agro-Technical Teacher Training Center.	By initial recruitment.
5.	Drawing Mistress, (BPS-14).	(a) Bachelor's Degree at least in Second Division from a recognized University; with Certificate in Drawing from a recognized Institution; or (b) Drawing Master Certificate or Intermediate Drawing Grade Certificate.	By initial recruitment."

(iii) after Serial No.5, as so amended hereinabove the following shall be inserted, namely,-

"5-A.	Physical Education Teacher, (BPS-14).	(a) Bachelor's Degree at least in Second Division from a recognized University; and (b) Diploma in Physical Education from a recognized Institution.	By initial recruitment."

(iv) after Serial No.5-A, as so amended hereinabove, the existing three entries which are without any number, shall be numbered 6, 7 and 8; and

(v) against Serial No. 6 as so numbered hereinabove, in column 2, the words and sign "Physical Training Instructor/" shall be omitted; and

(b) under Heading-II District Cadres, for Serial Nos.2 and 3, the following shall be substituted, namely,-

"2.	Junior Vernacular Teacher, (BPS-9).	(a) Higher Secondary School Certificate at least in Second Division from a recognized Board; and (b) Primary Teacher Certificate from a recognized Institution.	By initial recruitment.
