GRANT OF SPECIAL CONVEYANCE ALLOWANCE TO DISABLED EMPLOYEES:

Sir,

I am directed to refer to state that the Governor of the Punjab has been pleased to enhance the rate of Special Conveyance Allowance admissible to disabled employees of Punjab Government from existing Rs.1,000/- per month to Rs.2000/- per month in addition to normal Conveyance Allowance, with effect from 1st July, 2019. Following terms and conditions will be applicable for admissibility of this allowance:

- a) It will be allowed to those Punjab Government employees who have been appointed against disable employees' quota, or they have been declared/certified as disable by an authorized Medical Board thereafter during service.
- b) It will not be admissible during leave of any kind, except medical leave upto one month or casual leave.
