

3.	Municipal Corporations or Municipal Committees at the Tehsil HQs (as the case may be)	Assistant Commissioner of the tehsil concerned
4.	Municipal Committees in a Tehsil (other than Tehsil HQs)	Tehsildar of the tehsil concerned
5.	Town Committees in a Tehsil	Assistant Director Local Government (ADLG), LG&CD Department of the tehsil concerned
6.	Tehsil Councils of District HQ Tehsils	Deputy Commissioner of the district concerned
7.	Tehsil Councils of all other Tehsils	Assistant Commissioners of the tehsils concerned
