SUBJECT: UNIFORM RATES OF SUBSCRIPTION TOWARDS GENERAL PROVIDENT FUND

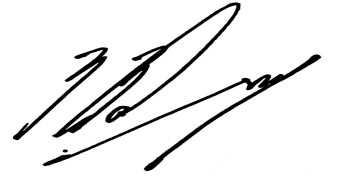

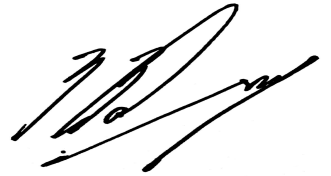
